INSTRUCTIONS

FORMS

- Legibly complete registration form on reverse side.
- Enclose registration (**checks payable to SJHS Foundation**)
- Complete 2 sets of artwork labels for all work submitted. Actual sticky-back labels must be secured to the back upper right corner of each artwork. Duplicate paper label sheet must be sent in with registration form by September 1, 2011.
- Along with the application, please submit a short bio and a self photo for use in the art show booklet.
- E-mail works best for photos (jpeg) and bios.
- Please list "on-file" to use your previous bio/photo.

DELIVERY

Artwork to be delivered on Friday, **September 9, 2011** to St. Joseph's Surgery Center from 9 -11:30 a.m.

ARTIST NOTIFICATION

Artists will be notified of acceptance by September 14, 2011. **All non-selected work must be picked up on Friday, September 16, 2011 from 9 - 11:30 a.m. Please mark your calendar!** Any questions should be directed to the SJHS Foundation Office at 362-0159.

ELIGIBLE MEDIA

Artist recognition is given in the following categories: Best of Show, First, Second, and Third Place overall. Honorable Mentions in each medium of watercolor, oil, pastel, acrylic, pencil, digitally enhanced photography, documentary photography and mixed media will be presented during the Meet the Artist Opening on Thursday, September 29, 2011 from 5-7 pm.

ENTRIES

- **Up to 6 entries allowed per artist.**
- **\$10 for 1-3 and \$20 for 4-6 pieces.**
- Submission of original artwork only.
- Open to all artists residing in Northern Michigan.
- Fees are non-refundable.



FRAMING STANDARDS

- **Please remove ALL hardware from the back of the frame prior to drop-off day, put into a ziplock bag, label, and bring in with your artwork.**
- **To properly attach required mounting brackets (provided by SJHS), frames must be a minimum of 1" wide and 1/2" in thickness. Please note that drilling will be required on all frames for mounting.**
- **All artwork must be framed or gallery wrapped canvas with no staples showing.**
- *****Minimum size is 16"W x 17"H framed.**
- *****Maximum size is 36"W x 40"H framed.**



SALE OF ART

All accepted artwork must be available for purchase. Artists are asked to clearly mark their selling price on each piece. SJHS Foundation receives 20% commission on all sold pieces to support the healing mission of St. Joseph Health System.

- SJHS reserves the right to photograph exhibiting art work for limited publicity purposes.
- All artwork must be original from the artist. No reproductions. **Please remove ALL hardware from the back of the frame prior to drop off day.** Please review the Framing Standards.
- SJHS reserves the right to refuse artwork that is too fragile, over/under-sized or does not meet conditions of eligibility. All artwork will be secured on walls with SJHS security brackets.
- Insurance coverage is the responsibility of the artist and is recommended at any art show.
- All artwork must remain on exhibit through March 11, 2012.
- **SJHS Foundation will receive a 20 percent commission on all sold pieces. Up to thirty additional pieces will be accepted as "Alternates" to replace art work sold by December 15. Jury reserves the right to choose individual art work from held pieces. The artist will receive payment for work sold by December 15, 2011 within four weeks. All sales of "Alternates" displayed will be paid within four weeks after the close of the show.**
